1. CALL TO ORDER

The Planning Commission meeting was called to order by Chairman Lee Riechel at 2:02 pm.

2. ROLL CALL

 - Chairman Riechel handed out his proposed revisions (round 3) to the Standards for Placement (155.2.3.200). After an extensive review by the Planning Commission it was decided that City Recorder Fred Hilden would attempt a rewrite to present at the September 27, 2011 Special Session.
 - Continuation of Chapter 155.2 code revision review. The review began at the beginning of Chapter 155.2.5.500.3 and stopped at the end of Chapter 155.2.6.700.
 - During the review of 155.2.6.500(C)(4) Vice-Chairman Burke made a motion to add the words "less than 75% of an" to this section. The new text will read, "Replacement of less than 75% of an existing structure in the same position with structures that do not disturb additional areas within the riparian corridor. Commissioner Beckman seconded the motion. The motion passed by unanimous vote.
