

Be it ordained by the City of Dunes as follows: Having been duly petitioned by the Citizens of the following described area, under authority prescribed by ORS ORDINANCE # 17 Chapter 222 for annexation.

AN ORDINANCE #17 CALLING A SPECIAL ELECTION FOR the approval or disapproval of a proposed annexation of contiguous territory to the City of Dunes, Lane County, Oregon, and directing that notice thereof be given:

Section 1. The City Council of Dunes, Lane County, Oregon ~~is~~ does hereby order that an election be held Tuesday, December 12, 1967, between the hours of 8 A.M. and 8 p.m. Pacific Standard Time, at which election the registered voters of the City of Dunes and the registered voters of the hereinafter described contiguous area seeking annexation shall cast their ballot for or against said annexation. The Polling place for the registered voters in the City shall be at Darlings Resort, North Beach, Dunes City, Oregon. The polling place for the registered voters in the area seeking annexation shall be at St. Paul American Luthern Church, Hwy. 101 South, Florence, Oregon. The legal description and map showing the area to be annexed is attached hereto and by reference incorporated into this Ordinance and made a part hereof.

Section 2. The City Recorder is hereby authorized and directed to publish the notice of said election by publication prior to such election, once each week for four successive weeks, in the Siuslaw News, Florence, Oregon, for four successive weeks on November 9, 1967 through December 12, 1967, inclusive. The City Recorder is further authorized and directed to post the notices of said election in four public places within the City of Dunes and four public places in the above described annexed territory proposed to be annexed for a period of four successive weeks prior to such election.

ANNEXATION DESCRIPTION

A tract of land lying in Section 2, 3, 10, and 11, Township 19 South, Range 12 West of Willamette Meridian and section 34 and 35 Township 18 South, Range 12 West of Willamette Meridian, Lane County, Oregon. Said tract being more particularly described as follows: Beginning at the one quarter corner on the section line between section 11 and section 12, Township 19 South, Range 12 West of Willamette Meridian; thence northerly along said section line, projected to the centerline of the main channel of the Siuslaw River, following the common section line between section 1 and 2, Township 19 South, Range 12 West, Siuslaw River, Willamette Meridian, and the section line between section 35 and 36, Township 18 South, Range 12, Willamette Meridian, to said point of intersection; Thence Westerly following the centerline of the main channel of the Siuslaw River to a point of intersection of the East line of the Northwest one quarter of the Northwest one quarter of section 34 township 18 South, Range 12 West of the Willamette Meridian; thence southerly along said one quarter line projected through section 34, 3, and 10, Township 19 South, Range 12 West, Willamette Meridian, thence Easterly along a line passing through the center of section 10 and section 11 to the point of beginning, to the one quarter corner of the section line between section 11 and 12, the point of beginning.
