ORDINANCE No. 27

AN ORDINANCE INITIATING THE ANNEXATION OF CERTAIN DESCRIBED CONTIGUOUS TERRITORY TO THE CITY OF DUNES CITY, LANE COUNTY, OREGON, CALLING A HEARING, AND DIRECTING THAT NOTICE BE GIVEN.

THE CITY OF DUNES CITY, OREGON, ORDAINS AS FOLLOWS:

I.

The Common Council of the City of Dunes City, Oregon, hereby initiates annexation proceedings for the annexation of the following described contiguous territory to the City of Dunes City, Lane County, Oregon:

The Northwest quarter of the Southwest quarter of Section 24, Township 19 South, Range 12 West of the Willamette Meridian, in Lane County, Oregon.

II.

The formal consent in writing having been filed by all of the property owners in the contiguous area which is the subject of annexation, the City Council of the City of Dunes City, Oregon, does hereby ordain and elect to dispense with submitting the question of said annexation to the registered voters of the City of Dunes City, Oregon.

III.

A hearing shall be held upon the proposed annexation herein provided, and said hearing shall be held on Monday, February 3, 1969, at the next regular meeting of the Dunes City Council, to be held at the Dunes City Fire Hall, in Dunes City, Oregon, at 8:00 o'clock p.m. Pacific Standard Time of said day, at which time all persons will be heard upon objections or remonstrances with reference to said proposed annexation and at said time the Council will consider the provide for said annexation of the above described contiguous territory or deny such annexation.

IV.

The City Recorder be, and he hereby is, required to forthwith publish the Notice of said hearing on said annexation, which notice shall be published once each week for two successive weeks prior to the day of hearing in a newspaper published in Florence, Lane County, Oregon, there being no newspaper published in Dunes City, Oregon (the newspaper selected by him is hereby designated as the official newspaper of the City of Dunes City for this purpose). Such notice shall give the description of the contiguous territory to be annexed as hereinbefore set out and shall state the date when this ordinance was passed, the date when the hearing on the proposed annexation is to be held, together with the statement that any objections or remonstrances may be made in person or in writing and filed with the City Recorder prior to the date of said hearing, which remonstrances at said hearing shall be heard and considered.

V.

The City Recorder shall forthwith and on or before the first publication of said notice post or cause to be posted notice of said hearing on annexation in four public places in the City of Dunes City, Oregon, which notice shall be posted for two successive weeks prior to the day of said hearing. Said notice shall be headed "Notice of Hearing on Annexation".

The posting and first day of publication of such notice shall be not less than two weeks before the time set for hearing.

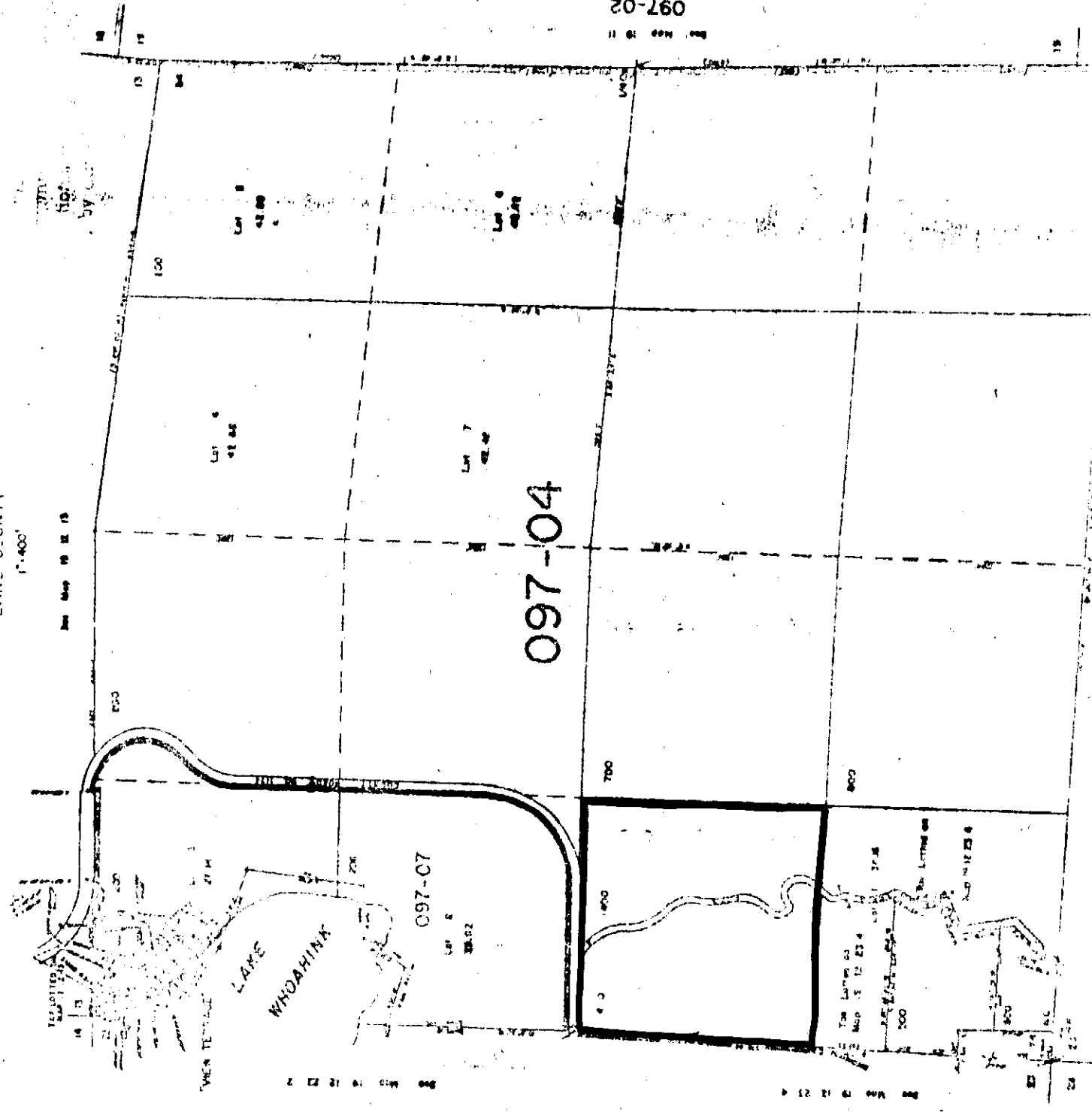
