ORDINANCE NO. 3/

Dunes City

AN ORDINANCE ANNEXING TO THE CITY OF DUNES CITY, LANE COUNTY, OREGON, CERTAIN CONTIGUOUS TERRITORY, PURSUANT TO THE PROVISIONS OF ORS 222.120 AND DECLARING AN EMERGENCY.

The City of Dunes City does ordain as follows:

Ι,

WHEREAS, all of the owners of the following described real property, to-wit:

That portion of the following described real property lying west of U.S. Highway 101: All that part of the following which lies within the bounds of Lot 4, Section 22, Township 19 South, Range 12 West of the Willamette Meridian, Lane County, Oregon, to-wit: BEGINNING at a point which is 825.62 feet North and 285.27 feet East of the Meander Corner between Sections 22 and 27 in Township 19 South, Range 12 West of the Willamette Meridian, Lane County, Oregon, said point being on the Westerly edge of State Highway 101; thence North 75° 30' West 159.0 feet; thence West 1087.47 feet; thence North 187.6 feet; thence East 1137.55 feet; thence South 75° 30' East 306.5 feet to a point on Woahink Lake; thence following the shore of Woahink Lake in a Southwesterly direction 200.0 feet, more or less to a point bearing South 75° 30' East 110.0 feet from the point of beginning; thence North 75° 30' West 110.0 feet to the point of beginning. EXCEPTING an 80.0 foot right of way of State Highway No. 101, as now located, and all located in Lane County, Oregon, and subject to easements, conditions and restrictions now of record.

AND ALSO: Beginning at a point on the west boundary of Lot 3, Section 22, Township 19 South, Range 12 West of the Willamette Meridian, said point being 365.0 feet north of the southwest corner of Lot 3, thence East 185.0 feet, more or less, to the Westerly boundary of Oregon Coast Highway right of way, which point is due west of Engineer's Station 231+50; thence following the westerly line of the highway right of way northerly 658.3 feet to a point due west of Engineer's Station 224+91.7; thence West to the West line of Lot 3, 500 feet, plus or minus; thence South along the west line of Lot 3, 570 feet, more or less, to the place of beginning, all in Lot 3, Section 22, Township 19 South, Range 12 West of the Willamette Meridian, in Lane County, Oregon,

have filed with the City Recorder of the City of Dunes City, Oregon, a written consent that such real property be annexed to the City of Dunes City, Oregon, and

WHEREAS, said real property is contiguous territory to the City of Dunes City, Oregon, and

WHEREAS, Ordinance No. 30 was heretofore passed, initiating the annexation of said contiguous territory, calling a hearing, and directing that notice be given thereon, which ordinance was duly passed by the Common Council of the City of Dunes City on April 7, 1969, and

WHEREAS, the hearing called for on the proposed annexation was held on Monday, May 5, 1969, at the Siuslaw Rural Fire Protection District Fire Hall on Clear Lake Road in Dunes City, Oregon at 8:00 o'clock p.m., Pacific Daylight Time,

at which time any objections or remonstrances with reference to said proposed annexation were considered by the Common Council of Dunes City, Oregon, and having heard any such objections and remonstrances with reference to said proposed annexation, the Council is of the considered opinion that said above described territory should be annexed to the City of Dunes City, Lane County, Oregon.

NOW THEREFORE,

The above described contiguous territory to the City of Dunes City, Lane County, Oregon, is hereby declared to be annexed to the City of Dunes City, and the City Recorder is directed forthwith to make and submit to the Secretary of the State of Oregon a copy of this ordinance, together with a copy of the written consent of the owners of all of the above described territory here annexed to the City of Dunes City, Oregon, and also a copy of the ordinance declaring that no election shall be required in said annexation proceedings within the said City of Dunes City, Oregon.

The Recorder is also directed to submit copies of this ordinance to the Director of the Department of Records and Elections, Lane County Court House, Eugene, Oregon, together with a map or plat of said territory, and to the Lane County Assessor and to the Lane County Surveyor, Eugene, Oregon.


