An Ordinance establishing a Park and Recreation Commission for the City of Dunes City, Oregon, and describing its duties.

The City of Dunes City, Oregon, ordains as follows:

- SECTION I. Establishment. A Park and Recreation Commission is hereby established for the city of Dunes City, Oregon.
- SECTION II. Membership. The Park and Recreation Commission shall consist of three (3) members who are residents but who are not officers or employees of the city.

 Two (2) members shall be members of the City Council to be used as advisors to the Commission.
- SECTION III. Term of Office. Except as provided in Section II, the members of the Park and Recreation Commission shall be appointed by the Mayor or City Council for a term of three (3) years. The initial appointments to the Commission shall be:

One Member whose term expires on June 30, 1984 One Member whose term expires on June 30, 1985 One Member whose term expires on June 30, 1986 Two City Council persons appointed by the Mayor for a term of one (1) year.

- SECTION IV. Presiding Member. In July of each year the Commission shall elect a Chairman and Vice-Chairman to serve for the following twelve (12) months.
- Meetings. A majority of the members of the Commission shall constitute a quorum. The Commission shall meet at least every three (3) months, at a regular time to be set by the Commission. The Chairman or two (2) members may call a previously unannounced special meeting to be held not earlier than twenty-four (24) hours after the notice is given. Notice of a previously unannounced special meeting shall be by telephone to Commission members, Mayor, local press representative and a notice shall be posted in the City Hall.
- SECTION VI. Duties. The Park and Recreation Commission shall serve as an advisory commission to the City Council and Mayor on matters concerning municipal parks and municipal recreation programs and facilities. Park and Recreation matters to be considered include;
